While a gift annuity can be funded in a number of ways, let's examine the benefits of transferring appreciated stock to charity.

The gift annuity graphic below shows how this works. Not only is there an immediate charitable income tax deduction but it is possible to bypass a portion of the capital gains tax on the sale of an appreciated asset.

In addition, the gift annuity may significantly increase income. Many donors appreciate the fixed payments. And the benefits don't end there. Of the annual income payment, a portion of the payment may be tax free.
