SCHOLARSHIP LIST BY CATEGORY

General/Biblical Studies

Christian S. Thomsen Scholarship

For students with financial need. Special consideration shall be given to those students whose intention is to become full-time missionaries. The student must maintain a 2.0 cumulative GPA for all course work. The student must evidence proven Christian character and conduct.

David Nettleton Christian Leadership Scholarship

For returning students that demonstrate exceptional leadership qualities. Must maintain a 3.3 cumulative GPA for all course work.

Esther Gee Dining Services Scholarship

For returning students employed in Dining Services. Must maintain a 2.3 cumulative GPA for all course work.

Faith Generations Scholarship

For students whose ancestors (not siblings) are alumni of FBBC&TS. Once awarded, this student will receive this scholarship each year (up to 4 years). Must maintain a 2.5 cumulative GPA for all course work.

Harold and Theodosia Gripp Scholarship

For returning students with financial need. Must maintain a 2.0 cumulative GPA for all course work.

Herbert Brudtkuhl Scholarship

For students working for the Maintenance/Housekeeping Department returning as sophomores or above. Must maintain a 2.3 cumulative GPA. Must be a current maintenance employee and have worked at least 200 hours in the past 12 months.

Irma Schwarck Scholarship

For students planning to enter a full-time specialized Christian ministry such as pastor, youth worker, missionary, Christian school, etc. Must maintain a 3.0 cumulative GPA and evidence proven Christian character and conduct.

John L. and Betty J. Hofmeister Scholarship

For students returning as juniors or above. Must maintain a 3.0 cumulative GPA and evidence proven Christian character and conduct. Must have successfully completed at least one year of study at FBBC&TS.

John L. Patten Scholarship

For students planning to enter a full-time specialized Christian ministry such as pastor, youth worker, missionary, Christian school, etc. Must be a junior or above, and maintain a 3.0 cumulative GPA and evidence proven Christian character and conduct.

Robert Moritz Scholarship

For students displaying financial need. Must maintain a 2.0 cumulative GPA for all course work.

Western Aid Scholarship

For students whose hometown is west of the Mississippi River. Must maintain a 3.0 cumulative GPA and be a sophomore or above who has successfully completed one semester at FBBC&TS.

William T. Roby Scholarship

For students returning as sophomores and above with financial need. Must maintain a 2.3 cumulative GPA for all course work.

Pastoral

Culberson Pastoral Student Scholarship

For returning students seeking to enter the ministry as a pastor or pastoral assistant. Must maintain a 2.7 cumulative GPA for all course work.

Dalton Cottrell Memorial Scholarship

For students returning as juniors or above in any of the Pastoral programs. Must maintain a 2.0 cumulative GPA required for graduation.

Domokos Excellence in Preaching Scholarship

For students seeking to enter the ministry as a pastor, pastoral assistant, missionary, or evangelist. Must be a senior or above and have completed at least one semester of Homiletics. Must maintain a 3.25 cumulative GPA and evidence proven Christian character and conduct.

Guy G. Godfrey Scholarship

For male students returning as juniors or above. Must maintain a cumulative GPA of 2.0 for all course work.

Joe and Dorothy Flatt Grade Point Scholarship

For students returning as juniors or above in the Pastoral or Assistant Pastor Programs. Must maintain a 3.0 cumulative GPA and evidence proven Christian character and conduct. Must have successfully completed at least one semester of study at FBBC&TS.

Ray and June Hitz Memorial Scholarship

For students returning as juniors or above who are seeking to enter the pastorate and have demonstrated good potential for the same. Must maintain a 3.0 cumulative GPA and evidence proven Christian character and conduct.

Education

Marilyn Saunders Scholarship

For students seeking to enter the Elementary Education program. Must maintain a 3.0 cumulative GPA and demonstrate financial need and evidence of proven Christian character and conduct.

William A. Tock Scholarship

For students seeking to enter a specialized Christian ministry in the area of Christian schools. Must maintain a 3.0 cumulative GPA and demonstrate good potential, and evidence proven Christian character and conduct.

Missions

Bernard and Eleanor Bancroft Missionary Scholarship

For students planning to go into full-time missionary service. Must be a sophomore or above and have successfully completed at least one semester of study at FBBC&TS. Must maintain a 2.33 cumulative GPA and evidence proven Christian character and conduct.

Davis and Reba Brown Memorial Scholarship

For students returning as seniors expecting to go into full-time missionary service/church planting. Special consideration will go to students looking into home missions or church planting in the US. Must maintain a 3.0 cumulative GPA for all course work.

Earl & Shirley Dannenberg M.K. Student Scholarship

For M.K.'s seeking to enter a missionary ministry. Must maintain a 2.0 cumulative GPA and evidence proven Christian character and conduct.

Far Eastern Missionary Scholarship

For students seeking to enter a missionary ministry, Asia being the most likely field, preferably going out under Baptist Mid-Missions. Must have completed at least one semester at FBBC&TS. Must maintain a 2.33 cumulative GPA.

Graham Student Missionary Scholarship

For students enrolled in the Missions program and seeking to enter a missionary ministry. Must maintain a 2.0 cumulative GPA. Must evidence proven Christian character and conduct and have demonstrated potential for missions work.

Irwin A. Weyhe Missionary Ministries Scholarship

For students planning to enter a missionary ministry. Must have completed at least one year of study at FBBC. Must have maintained a 2.33 cumulative GPA.

Schildroth Missions Scholarship

For returning students as juniors or above expecting to enter a missionary ministry in the US. Must maintain a 2.0 cumulative GPA for all course work.

Willard and Grace Stull Missionary Scholarship

For students planning to enter a missionary ministry. Must be a returning senior or above, have completed at least one year at FBBC&TS. Must maintain a 2.33 cumulative GPA and evidence proven Christian character and conduct.

Music

Charles Bergerson Music Scholarship

For students seeking to go into a specialized Christian ministry in music and have demonstrated good potential for the same. Must be a returning junior or above and have successfully completed at least one semester at FBBC&TS. Must maintain a 2.33 (C+) cumulative GPA and evidence proven Christian character and conduct.

Faith Chorale Accompanist Scholarship

Recipient must be a member of the Faith Chorale and will be selected annually to serve as the accompanist, and must maintain required practice, rehearsal and performance schedules. Must also maintain a 2.0 cumulative GPA. The student does not need to be a music major.

Neva Rittgers Music Scholarship

For students who are members of an FBBC&TS musical ensemble. The student must be enrolled in private music lessons. The student does not need to be a music major.

William David Dougherty Music Scholarship

Recipient must be involved in an orchestral music group at Faith, evidence proven Christian character and conduct, and meet all other eligibility requirements. The student does not need to be a music major.

SCHOLARSHIP REQUIREMENTS

Students receiving endowment scholarships:

- Must be enrolled full-time (12 credits or more) for both fall and spring semesters of the academic year.
- 2. Must maintain satisfactory academic progress (see financial aid handbook).
- 3. Must maintain minimum GPA requirements of 2.0 or as specified by the individual scholarships.
- 4. Must be taking classes in person.

If any scholarship listed would cause the student to be over-awarded after all other grant and scholarship monies are awarded, the student will be awarded only the amount for which he/she is eligible. Excess funds will not be carried over from semester to semester or year to year. Not all available scholarships are included. Funding may not be available for every scholarship listed from year to year.
